

WS01: Don't Chase Waterfalls: Polypharmacy and Prescribing Cascades of Today (3.25 CE, 3.25 RX, .5 G)

This program highlights the resurgence of polypharmacy and prescribing cascades since the 1990s. It will help providers determine the difference between side and adverse effects and identify the most common medications in prescribing cascades. After completing this program, providers should be able to know the difference between problems found with polypharmacy and medication prescribing cascades, and be able to prevent and correct medication therapy that may be inappropriate for their patients.

Speaker: Dr. Ashley Garling, PharmD

Dr. Garling graduated Rho Chi with honors from the MCV/ Virginia Commonwealth University School of Pharmacy. She is now a clinical assistant professor at The University of Texas at Austin College of Pharmacy, serving as a communication, media, and patient engagement specialist. Dr. Garling is the principal investigator (PI) and Co-PI for research projects in community pharmacy settings spanning telehealth, HIV PrEP, mental health, patient counseling, and medication adherence. She is the president of the Capital Area Pharmacist Association, and is a Public Policy Council Member of the Texas Pharmacist Association.

WS02: Documentation, Coding, and Billing: Know Your Value and Worth (3.25 CE)

NPs are revenue generators and receive little to no education as to its importance. How you and your services are billed matters. You are responsible for what you document, code, and bill. This session will help you accurately document, code, and bill for your services as well as provide tools to understand practice and organizational revenue flow. You will learn how to protect yourself from unintended consequences that can affect your ability to practice.

Speaker: Dr. Lynn Rapsilber, DNP, APRN, ANP-BC, FAANP

Dr. Rapsilber graduated with a Doctorate in Nursing Leadership from Quinnipiac University in May 2016. As the owner of NP Business Consultants, LLC, Dr. Rapsilber disseminates information regarding reimbursement for nurse practitioners and other health care provider services. She is recognized as an expert on coding and documentation for APRNs. She also serves as the Co-Chair of the Connecticut Coalition of Advanced Practice Nurses. Under her leadership, full practice authority for APRNs in Connecticut was attained with Public Act 14-12. She also owns NP Wellness Care, LLC, providing Hepatitis C treatments at residential and addiction treatment centers.

WS03: Dermatology Skills for the **Primary Care Clinician** (3.25 CE, .5 RX, .5 G, .5 E/J)

Sorry, workshop full

This three-hour dermatology workshop will equip NPs with tools for treating common skin conditions that may require simple dermatologic procedures. Content includes the initial skin assessment, clinical evaluation, and evidence-based management for patients who present in the family practice setting. The cases presented utilize minimal equipment and can be safely and easily performed during regular clinic visits. Hands-on skills demonstration and/or practice will be available and include administration of local anesthetics, shave biopsy, scissor excision, and cryotherapy.

Speaker: Dr. Kathileen Boozer, DNP, MSN, APRN, FNPC

Dr. Boozer is an owner operator of Inspired Skin+Wellness Dermatology Clinic. She completed a dermatology internship in 2014 and has been practicing as a specialist in this field since. WS04: Basic Suturing for APRNs (3.25 CE, .5 RX)

This hands-on workshop teaches the fundamentals and principles of basic suturing for the advanced practice nurse. We will discuss principles of wound healing, various suture materials and instruments, injectable anesthetic options, foundational suturing techniques, and appropriate wound care and follow-up. Hands-on skills demonstrations and practice will be provided by two experienced clinicians in a non-threatening and friendly manner.

WS05: 12 Lead EKG Basics and Beyond (3.25 CE, 1 RX, .5G, .5E/J)

12 Lead EKG will include a brief review of the basic rhythm and physiology of heart conduction and contraction, leading to advanced 12 Lead EKG reading, understanding, and recognition of dangerous arrhythmia by using case studies. Attendees will be able to distinguish what is normal/abnormal rhythm and what is dangerous or what needs a referral.

Speaker: Dr. Jose L. Villa, DNP, APRN, FNP-BC

Dr. Villa completed his Doctorate in Nursing Practice from the University of the Incarnate Word with his Capstone project geared toward the management of patients with atrial fibrillation and minimizing hospital readmissions in a large military institution. He was honorably discharged from the Air Force and has over 20 years of experience in disciplines of family practice, internal medicine, cardiothoracic surgery (congenital heart disease), interventional cardiology, and electrophysiology. He owns Villa Family Clinic and works with 5 Star Integrity Healthcare in San Antonio, Texas.

WS06: Joint Injections Workshop (3.25 CE)

Sorry, workshop full

This workshop will provide an evidence-based review of the indications and contraindications for joint and soft tissue injections commonly encountered in primary care practice. An overview of the medications including preparation and dosing for joint and soft tissue injections will be provided. Pertinent history and examination along with joint anatomy and common mechanisms of injury of the various joints and anatomical structures commonly injected including knees, shoulders, and trigger fingers will be reviewed. After discussion and demonstration, attendees will have the opportunity to practice with provided supplies and models. This program is for new practitioners or those who want a refresher.

Speakers: Amelia Leal-Serrata, APRN, FNP-BC and Karen Scherger, APRN, ACNP-BC

Amelia is a board-certified Family Nurse Practitioner. She has worked at Parkland Health and Hospital System for 22 years, and recently celebrated her 9th year with the the Orthopaedic Department. Parkland is a level I Trauma Center and provides care to all patients regardless of financial status. Patients seek care for complex, acute and chronic orthopaedic conditions. Aside from patient care, she enjoys volunteering to promote health and wellness in Dallas County with the Dallas Independent School District.

Karen is a certified Acute Care Nurse Practitioner. She has worked at Parkland Health for over 30 years, including more than 11 years as an NP in the Orthopedic Department. The Orthopedic Department at Parkland is a large team that provides care to all patients regardless of funding and with a wide variety of complex orthopedic problems.

WS07: Opioids Workshop (3.25 CE, 3.25 DEA, 3.25 O)

In response to the opioid epidemic and variations in clinical practice, new practice recommendations, guidelines, and to provide requirements for managing patients with pain have been published. This educational presentation aims at providing APRNs with the most current clinical information to aid in clinical decision making and patient engagement when seeing patients with pain complaints. Using a multimodal model and a biopsychosocial approach to patient care. APRNs can appropriately screen for risk, appropriately treat patients with pain, and identify substance use behaviors. This presentation will meet requirements for CE that can be applied to DEA and Texas BON APRN license or renewal.

With the 89th Texas Legislative Session around the corner, now is the time to learn about the key issues for which TNP advocates in the Texas legislature to remove practice barriers for Texas NPs and expand access for patients. TNP's Government Affairs and lobbying teams will provide updates on new bills and regulations implemented in 2024, offer insights into the political landscape as we approach the General Elections in Texas, and do a deep dive into TNP's legislative agenda for 2025.

F01: Congestive Heart Failure: Updated Guidelines and Patient Specific Management Strategies (1 CE, .5 RX, .5 G)

This program will delve into the various phenotypes of heart failure, including heart failure with reduced and preserved ejection fraction, as well as a discussion of primary rightsided heart failure. The presenter will discuss guidelinedirected medical therapy (GDMT) for the various phenotypes of heart failure, including important recent additions to GDMT of which practitioners should be aware. Patient cases/scenarios will be incorporated to assist the practitioner with developing patient-specific plans of care while encouraging audience interaction with these scenarios.

Speaker: Dr. Buffy Powell, DNP, APRN, ACNP-BC

Dr. Powell, is a board-certified acute care nurse practitioner. Her specialty is adult cardiovascular care. She is employed by Cardiac and Vascular Center of North Texas in Fort Worth, Texas. Previously, Buffy worked for Permian Cardiology in Midland, Texas for over 20 years. She has been on the faculty at the University of Texas at Arlington (UTA) College of Nursing and Health Innovation since 2018. Her current teaching responsibilities are in the Adult-Gerontology Acute Care Nurse Practitioner program.

F02: COVID19: A Crisis of Confidence Across the Pediatric Care Continuum (1 CE)

Since the rapid emergence of the novel coronavirus in December of 2019, clinicians around the world have struggled to understand and respond effectively in health care systems already strained before this latest viral outbreak. Nurse practitioners are ideally suited to serve as a trusted source of health information for children. This presentation summarizes the latest evidence on holistic health impacts of COVID-19 on children and their families.

Speaker: Dr. Jessica Peck, DNP, PARN, CPNP-PB, CNE, CNL, FAANP, FAAN

As President of the National Association of Pediatric Nurse Practitioners, Dr. Peck created the Alliance for Children in Trafficking and served as founding chair. Dr. Peck holds active credentials as a Pediatric Nurse Practitioner, Certified Nurse Educator, and Clinical Nurse Leader. She is editing the first interprofessional pediatric Covid-19 textbook in the world. She has published more than 50 clinical articles for peer-reviewed journals, is a regular contributor for parenting magazines and a frequent guest on radio, television, and other media.



F03: Lung Cancer: From Screening to Management (1 CE, .5 RX, .5 O)

Lung cancer remains the leading cause of cancer death in the U.S. Early detection is a hallmark of survival, and Nurse Practitioners are in a prime position to provide support in a lifesaving multidisciplinary team of clinicians. This program will discuss screening, referral avenues, and will briefly describe optimal treatment pathways.

Speaker: Aaron Rossett, APRN, FNP-BC, ACNP-BC

Aaron is an APRN with the Department of Cardiothoracic Surgery at the University of Texas Health Science Center at San Antonio. His specialty interest is adult surgical disease of the chest. With a dedicated Thoracic Surgery Team, he provides minimally invasive surgical care for lung cancer management in collaboration with a multidisciplinary Tumor Board in San Antonio, TX.

F04: Augmented Reality in Advanced Practice Nursing **Collaborative Care Simulation (1 CE)**

Graduate faculty developed and implemented a collaborative care simulation case for advanced practice nursing students in the FNP and PMHNP programs. This presentation will outline the planning process, implementation, and results of this novel experience combining augmented reality technology and collaborative care principles.

Speakers: Dr. Tracey Smith, DNP, APRN, FNP-BC and Dr. Kathy Smith, EdD, APRN, FNP-BC, ACNP-BC

Dr. Smith is a family nurse practitioner and graduate faculty at Texas State University. She has used her knowledge and experience with simulation in advanced practice nursing education to develop or revise simulation cases for all ages at two major universities in Texas. She educates students in both the FNP and PMHNP programs at TXST and actively participates in professional efforts to advocate for the advanced practice nursing profession.

Dr. Kathy Smith is the Graduate Program Director and an Assistant Professor at Texas State University. She has over 20 years of experience in nursing practice, education, and higher education administration. Dr. Smith has served as faculty, a curriculum expert, and in academic nursing director roles. She is dually board-certified as an Acute Care and Family Practice Nurse Practitioner.

F05: Cardiogenic Embolic Stroke and Its Management (1 CE, .5 RX, .5 G)

According to the CDC, in 2021, one in six deaths from cardiovascular disease was due to stroke. Stroke is the second leading cause of death and the third leading cause of disability worldwide. This session will discuss the concept of cardiogenic causes of stroke, the importance of the role of cardiac monitoring, and early detection of occult atrial fibrillation to prevent the recurrence of stroke.

Speaker: Dr. Rose Bagh, DNP, APRN, FNP-BC, AGACNP-BC

Dr. Bagh is a dual board-certified NP with family practice and acute care NPs, doctorly prepared with a DNP. She works in an Inpatient Stroke Unit at one of the largest teaching hospitals, Parkland Health and Hospital System. Previously, Dr. Bagh worked with a group of cardiologists who provided her with better insight into the cardiogenic causes of stroke and its management and prevention.

F06: Delirium in the Acute Care Setting: Early Detection is Key (1 CE, 1 G)

Delirium is a common life-threatening and often preventable clinical syndrome in older adults. It is one of the most commonly occurring neuro-psychiatric conditions among older adult patients, and its significance as a grave prognosticator is well established. Regardless, delirium continues to go unrecognized and continues to be managed inadequately. This session will discuss prevention and early identification of delirium as keys to survival.

Speaker: Dr. Deanna Adams, DNP, APRN, AGACNP-BC, FNP-C, GS-C, CEN

Dr. Adams is the owner of Adams NP Medical Services, PLLC. Dr. Adams practices in long-term care and a rural emergency department in East Texas. She also works with renal patients in the dialysis unit. She serves as the Acute and Emergent Care SIG chairperson and is a member of the conference planning committee in the Gerontological Advanced Practice Nurses Association and the National Kidney Foundation Clinical Meetings planning committee.

F07: The Signs of Burnout and Strategies for Promoting **Optimal Wellness for Ourselves and Our Patients** (1 CE, .5 E/J)

This interactive presentation will explore healthcare provider burnout and compassion fatigue, focusing on recognizing the five stages of burnout and active strategies to prevent and counteract job-related stress. Come refill your self-care and self-compassion bucket!

Speakers: Dr. Cara Young, PhD, APRN, FNP-C and Dr. Chris Divin, PhD, APRN, FNP-BC

Dr. Young is an associate professor and Director of the Family Nurse Practitioner Program at UT Austin. Her research examines and seeks to improve behavioral and psychosocial transitions for vulnerable populations in the first half of the life course. Her primary line of research has focused on improving the mental health of children, adolescents, and young adults through mindfulness-based interventions.

Dr. Divin is a Clinical Assistant Professor of Nursing in the FNP program at the University of Texas at Austin School of Nursing. She is a Family Nurse Practitioner with over 25 years of primary care experience as an FNP. She is passionate about promoting well-being in her patients, students, and fellow healthcare professionals. Dr. Divin serves on TNP's Wellness Committee.



F08: Texas Law and the NP Scope of Practice - Part 1 of 2 (1 CE. 1 E/J)

The scope of practice for the nurse practitioner extends beyond the Texas Board of Nursing's Nurse Practice Act and regulations. Additional Texas State laws also impact NP's scope of practice. This session will explore how Texas State laws shape the NP's scope of practice.

Speakers: Dr. John Gonzalez, DNP, APRN, ACNP-BC, ANP-C and Dr. Kristin Gigli, PhD, APRN, PNP-AC

Dr. Gonzalez teaches full-time at the University of Texas Medical Branch at Galveston, maintains a part-time practice with the hospitalist service at Parkland Health, and has his own telemedicine practice, Holistic Integrative Health, where he practices functional medicine. Additionally, he owns APRN Professional Practice Consultants and provides scope of practice consultations to individuals and institutions, patient advocacy services, and medical-legal consulting. He is a TNP Scope of Practice committee member.

Dr. Gigli's research examines the roles of advanced practice providers providing care to hospitalized children and policies related to nurse practitioner scope of practice. She works in the Pediatric Intensive Care Unit at Children's Health Dallas and is a past board member of the National Association of Pediatric Nurse Practitioners. She is the current liaison to the American Academy of Pediatrics Committee on Hospital Care.

F09: Wound Care Made Easy - From the Office to the ICU (1 CE, .5 RX, .5 G)

As frontline providers, APRNs must be able to identify, assess and develop an effective treatment plan for healing acute and chronic wounds. This session will review the differences among the many types of wounds and inform treatment decisions using evidence-based care guidelines for patients with complicated wounds. Pictures of complicated patient wounds and case studies with Q&A incorporated are part of the interactive learning process.

Speaker: Lisa Ginapp, MSN, APRN, AGACNP-BC, WCC, DWC,

Lisa is a self-employed, Board-Certified Adult and Gerontological Acute Care Nurse Practitioner with national certification as a wound care specialist, a diabetic wound care specialist, and an ostomy management specialist. Lisa provides advanced practice nursing management of acute and chronically ill patients in two acute care hospitals and two outpatient clinics and makes home visits to patients in a 100mile radius. Lisa is also retained as an expert witness for case reviews of lawsuits across the country.

F10: Attention Deficit: ADHD and its Analogues, How to Differentiate, Diagnose, and Treat (1 CE, .5 RX, .5 G)

This session aims to remove misconceptions about ADHD, introduce key psychiatric analogues, address some physical conditions responsible for symptoms, and teach easy tools to enable discriminatory diagnoses. The presenter will discuss medications that are safer than stimulants for treating ADHD and some analogue conditions and help understand when psychometric evaluation of intelligence and executive function and attention testing are needed.

Speaker: Justin Scaffa, PMHNP

Justin has over 7 years of experience in psychiatric care. He has most recently been trained and certified as a forensic mental health evaluator, in which capacity he administers class C psychometric testing for ADHD and other neurocognitive and mental health disorders and can testify as an expert witness in court. He has inpatient and partial hospitalization experience with substance abuse patients and even has the ability to prescribe Subutex.

F11: Maternity Care Deserts and APRN Impact (1 CE, .5 E/J)

Maternal morbidity and mortality in the United States remain a significant public health concern, with the highest rates of maternal mortality among developed nations. A significant correlation exists between increased maternal morbidity and mortality and residing in a maternal care desert. Understanding the impact of maternal care deserts on social determinants of health will allow APRNs to better position themselves to be patient advocates and decrease the incidence of maternal care deserts in Texas.

Speaker: Dr. Antay Waters, DNP, APRN, WHNP-BC, CNM, CNE. CRNFA

Dr. Waters is a board-certified women's health nurse practitioner, certified nurse midwife, certified registered nurse first assist, and certified nurse educator in East Texas. She remains a certified perioperative nurse. She is currently an Assistant Professor of nursing, an OB Triage APP, and she owns a surgical first assist practice. Dr. Waters has presented and published on a variety of topics ranging from women's health, postoperative pain management, and cardiovascular health to healthcare risk management through error reduction.



F12: Texas Law and the NP Scope of Practice - Part 2 of 2 (1 CE, 1 E/J)

GS05: Neuroplasticity: Importance of Brain Health brought to you by Texas Nurse Practitioner Foundation Kim Oas Memorial Fund (1 CE)

Understanding neuroplasticity and how brain health can be included in your existing practice is the focus of this presentation. Neuroplasticity is the brain's ability to change its own structure and functioning in response to nutrition/ toxicity, emotional, or mental experience. It is a flexible organ that adapts to change across the age span. The discussion will include how brain health can be measured and improved, highlighting a four-phase program of detoxifying, nourishing, enlivening, and training the brain.

An internationally recognized licensed psychologist, Dr. Peavey received her doctoral degree from the University of North Texas in Behavioral Medicine and Clinical Psychology. She holds a post-doctoral degree in Psychopharmacology. With 45 years of clinical experience, she is a pioneer in biofeedback, self-regulation, and brain health. Since 2004 Dr. Peavey has directed the PsychoNeuroPlasticity (PNP) Center, with a multifaceted professional team working together to understand and develop treatment programs for brain-based disorders.

S13: Look at Those Legs! Differentiation and Treatment of Lower Extremity Wounds (1 CE, .5 RX, .5 G)

Her work has been published, and she has presented nationally to healthcare professionals on how to improve healthcare engagements for those with autism.



S15: Avenging Breast Cancer: Current Progress, Our Arsenal, and the Road to Victory (1 CE, 1 RX, .5 G)

It is hard to meet anyone who has not been affected by cancer. Breast cancer is one of the top 5 most common cancers we encounter in medicine. Fortunately, we have come a long way in the fight against cancer. This presentation will take the audience on a journey of how we are currently fighting breast cancer and the promising therapies on the horizon. The presenter will also discuss how all practitioners can aid in the fight against breast cancer and how they can work with their oncology colleagues to best serve their mutual patients.

Speaker: Dane Thomas, PA-C

Dane is a physician assistant with over 13 years of experience, primarily in radiation and medical oncology. He currently works as a Hematology/Medical Oncology Physician Assistant at Texas Oncology in Dallas, TX.

S16: Controlled Substance and Pain: Management of Pain in any Setting: Rules, Regulations, and Clinic-Based Considerations (1 CE, .5 RX, .5 E/J, 1 O)

This seminar targets APRNs practicing in any practice environment initiating or continuing treatment of pain syndromes. The information is designed to inform and update the audience regarding best practices. S17: Inpatient Management of Alcohol Withdrawal (1 CE. .5 RX)

This lecture is for emergency department and inpatient providers who encounter patients with acute alcohol withdrawal syndrome. Discussion of patient risk factors, symptoms, and use of the Clinical Institute Withdrawal Assessment for Alcohol (CIWA) will occur. The presenter will compare the various pharmacological regimens used for the prevention and treatment of alcohol withdrawal syndrome utilized in the emergency department, inpatient medical unit, and intensive care unit.

Dr. Hext is a quadruple board-certified nurse practitioner with a passion for children's mental health. She serves as an assistant professor and works in primary care pediatrics serving at-risk children. She has her own psychiatric practice serving both children and adults.

Dr. Seaman has expertise in inpatient and outpatient mental health. He is also an experienced educator who has taught in undergraduate and graduate mental health programs. His research interest includes childhood trauma, the effects of experiential education, the personality types of university faculty, and immersive learning.

S19: Imaging Stewardship: A Primary Care Provider's Guide to Treating and Referring Patients with Musculoskeletal Conditions (1 CE, .5G)

This presentation will provide Primary Care Providers (PCPs) a guide when treating patients with musculoskeletal conditions and ordering imaging. Knowing how to perform a focused exam, documentation, diagnostic testing, and treatment owers costs, improves patient outcomes, and expedites referral to orthopedics.

Amelia is a board-certified Family Nurse Practitioner. She has worked at Parkland Health and Hospital System for 22 years, and recently celebrated her 9th year with the the Orthopaedic Department. Aside from patient care, she enjoys volunteering to promote health and wellness in Dallas County with the Dallas Independent School District.

Karen is a certified Acute Care Nurse Practitioner. She has worked at Parkland Health for over 30 years, including more than 11 years as an NP in the Orthopedic Department. The Orthopedic Department at Parkland is a large team that provides care to all patients regardless of funding and with a wide variety of complex orthopedic problems.



S20: Big Problems from Small Biters: The Latest on Mosquito-Borne, Tick-Borne, and Other Vector-Related Diseases of **Concern in Texas** (1 CE)

Incidence of vector-borne diseases (VBDs) is increasing in Texas and other areas in the U.S. Understanding where patients are at risk and the need for treatment based on a presumptive diagnosis can help manage outcomes. Timely treatment is essential since some VBDs can be quickly fatal and/or have lasting sequelae. Proper tick removal and evidence-based bite prevention strategies are essential for Nurse Practitioners to know.

Speakers: Dr. Elizabeth (Libby) Carver, DNP, FNP-BC, CNE and Dr. Mustapha Debboun, PhD, BCE Fellow ESA

Dr. Carver works in employee health and travel medicine in the Duke University Health System. A graduate of The University of North Carolina (Chapel Hill) with degrees in psychology and nursing, she earned her doctorate at Garner-Webb and her nurse practitioner degree at Duke. Her career at Duke spans more than 20 years in patient care, research, and education.

Dr. Debboun, a world-renowned medical and veterinary entomologist, has authored five books and more than 135 publications. He has organized and moderated symposia for the International Congress of Entomology. He developed the only national and international field training package for military personal protection from vector-borne diseases (VBDs) in the Middle East, implemented by more than 250,000 military personnel.

S21: Hypothyroidism: It's So Much More Than T4 (1 CE, .5 RX)

Hypothyroidism is one of the most diagnosed illnesses, and levothyroxine is one of the most frequently prescribed medications in the U.S.; however, some mechanisms of the thyroid are still not well understood. This session will discuss the changing atmosphere surrounding the future of hypothyroid treatment and how the addition of liothyronine (T3) could help patients to feel optimal and relieve them of chronic, unresolved symptoms.

Speaker: Sandy McCoy, BSN, MSN, FNP

Sandy began in bariatrics in 1979 when she helped to open one of the first bariatric units in Dallas, Texas. She again got involved with bariatrics in 2003 when she became Dallas's fifth bariatric band patient. She was very active online with bariatric support and began full-time work in several bariatric surgical practices. In the last 10 years she has had her own bariatric practice in Plano, Texas called Believe Bariatrics and Primary Care. She is very passionate about caring for the bariatric patients both medically and surgically if indicated and educating others that obesity is a disease.

S22: Updated Guidelines on Undiagnosed Maternal Mental Health Conditions Across Primary Care Settings (1 CE)

Maternal mental health conditions (MMHCs) pose a notable public health challenge, impacting not only mothers but also their children and families. Many cases of MMHCs remain undetected and untreated. This presentation seeks to equip and empower APRNs with a comprehensive knowledge and thorough understanding of prevalent MMHCs, including diagnosis, management strategies and updated 2023 American College of Obstetrician and Gynecologist guidelines pertinent to their practice.

Speaker: Sandra Kolapo, DNP, APRN, PMHNP-BC

Sandra is the interim Program Director for the Psychiatric Mental Health Nurse Practitioner (PMHNP) program at the University of Texas at Tyler. She also owns and operates an outpatient mental health clinic in North Houston. With 14 years of nursing experience and 8 years specializing in maternity and mental health. Sandra is dedicated to bridging the gap between nursing care and mental health, aiming to reduce mortality and suicide rates by addressing mental health issues earlier.

S23: Rheumatology Lab Interpretation and Management of Autoimmune Disorders in Primary Care (1 CE, .5 RX, .5 G)

Session speakers will review the most common rheumatologyrelated laboratory assessments, and discuss the significance of autoantibodies associated with various rheumatology conditions and how these findings should be interpreted. In addition, the session will cover how to best manage autoimmune disorders collaboratively between rheumatology and primary care providers with a focus on pharmacologic treatment risk mitigation in the primary care setting.

Speakers: Dr. Susan Quisenberry, DNP, APRN, FNP-C, CNP and Dr. Susan Chrostowski, DNP, APRN, AGNP-C

Dr. Quisenberry is a clinical professor at Texas Woman's University College of Nursing. She is a certified family nurse practitioner and, for the past 15 years, has worked exclusively with rheumatology clients. Her practice and scholarship activities are focused on patients with rheumatoid arthritis. She served as a clinical sub-investigator on over 150 rheumatologyfocused clinical trials and published articles related to rheumatologic conditions.

Dr. Chrostowski is an associate clinical professor at Texas Woman's University and a practicing certified adult nurse practitioner. She has been working exclusively in rheumatology since 2005. Beyond her ongoing clinical practice with rheumatology patients, she has presented at local and national conferences on rheumatologic conditions, published articles related to rheumatology conditions, and served on multiple national rheumatology committees. Dr. Chrostowski is currently a board member on the American Board of Internal Medicine - Rheumatology Sub-Specialty Board.



S24: Pediatric Obesity (1 CE)

Pediatric obesity is a growing epidemic with associated cardiovascular and metabolic complications including hypertension, diabetes mellitus, hyperlipidemia and sleep apnea. This interactive presentation will guide frontline primary care providers through the optimal selection of medication for obesity management in pediatric patients. Additionally, our presenter will review medication side effects, necessary drug monitoring and behavioral strategies, as well as available surgical treatments. The presentation will cover overlapping type 2 diabetes condition and treatment options.

Speaker: Mili Vakharia, APRN, FNP-C, CDCES

Mili is an assistant professor in the Division of Pediatric Diabetes and Endocrinology at Texas Children's Hospital, Baylor College of Medicine. She has been a nurse practitioner for over 12 years, with the last 5 years in pediatric diabetes. She is a member of NAPNAP's pediatric obesity SIG and Education Committee at the Pediatric Endocrine Society. She also coleads the diabetes education quality improvement team at Texas Children's Hospital which focuses on improving the use of diabetes technology and cardiovascular screenings, reducing healthcare disparities and implicit biases while enhancing education.

S25: Lend an Ear: Auricular Therapy Protocols for Pain Management (1 CE, .5 E/J, .5 O)

Pain is a very common complaint and quickly reduces quality of life. In this day of opioid abuse and polypharmacy, NPs who are on the frontlines in primary care, need alternatives that do not cause more side effects. This presentation includes several case presentations.

Speaker: Dr. Karen Williams, DNP, FNP-BC, FAANP, AQH

Dr. Williams has 40 years' experience in the health care field, with an extensive experience in utilizing an integrative approach to pain and headache management. Prior to her retirement from the VA, she was a member of the Office of Nursing Service Pain Committee, serving as a subject matter expert for alternative medicine and the use of acupuncture for pain reduction in the Veteran population. She completed a 300-hour medical acupuncture program in 2013 and has a national certification in auricular acupuncture and certification as a Battlefield Acupuncture Instructor.

S26: Unipolar Depressive Disorders: The Old, the New in Managing the Blues (1 CE, 1 RX)

Seeking new ways to treat depression in your practice? Options include newer antidepressants on the market such as brexpiprazole, cariprazine, vortioxetine, bupropion/ dextromethorphan, esketamine, bexanolone, and zuranolone to mention the buzz about ketamine. This session will examine and compare new and old antidepressants and adjunctive psychopharmacology and discuss best practices, when to refer to psychiatry, and options for treatment-resistant depression.

Speaker: Kimberly Giberga, MSN, APRN, FNP-C, PMHNP-BC

Kim has been a nurse practitioner for 15 years and opened her own patient-centered psychiatric practice in San Antonio, Texas in 2023, treating patients aged 13-65 in person and via telehealth. She is the founder of Female Providers of San Antonio, a group of 449 NPs, CNSs, PAs, MDs, and DOs dedicated to promoting networking, mentoring, continuing education, and equality of both pay and leadership opportunities for women in healthcare.

S27: An Evidence-Based Contraception Update for the Primary Care Provider (1 CE, .5 RX, .5 E/J)

This presentation will cover the current rates of contraception use and unintended pregnancies in the US, disparities of use as well as the different types of hormonal and non-hormonal contraceptive options. We will discuss options of barrier, reversible, non-reversible, and emergency. This presentation will address the 2016 CDC medical eligibility criteria, special recommendations for contraceptive use, and the CDC app available for clinicians.

Speaker: Dr. Padmavathy Ramawamy, PhD, MPH, APRN, **FNP-BC**

Dr. Ramaswamy is an Assistant Professor in the Department of Graduate Studies at Cizik School of Nursing, University of Texas Health Science Center at Houston. She has been a practicing family nurse practitioner for 24 years. Her clinical experience spans the population and age spectrum, and she provides contraceptive management to the college population at UH and other women's health services. Her research interest focuses on the use of technology in disease prevention and health promotion.

S28: Skin Cancer Cases: What You Need to Know. (1 CE, .5 RX, .5 G, .5 E/J)

In a case study format, our presenter will review cutaneous cancers, including basal cell carcinoma, squamous cell carcinoma, and melanoma, that can present in young adults and geriatric patients. This presentation aims to help nurse practitioners develop a clinical approach to the initial evaluation, diagnosis, and management of skin cancers.

She is an active member of transdisciplinary research teams investigating the use of virtual simulation technology for prevention and early diagnosis of skin cancer and community-based wellness initiatives to improve socialization, healthy habits, and health in rural India.

Management of Pacemaker-Induced Cardiomyopathy: **A DNP Student-Led Project**

The only effective treatment for symptomatic bradycardia is the implantation of a permanent pacemaker. While pacemakers are life-saving devices, a high percentage of right ventricular pacing can lead to the development of pacemaker-induced cardiomyopathy (PICM). Identifying those at risk for PICM and ordering annual echocardiograms is essential in this patient population. Educating the primary care team on these guidelines is essential to improve outcomes.

Implementation of Diabetes Risk Screening in a Rural Texas **Urgent Care**

This presentation outlines a quality improvement project that implemented a diabetes risk screening program in a rural Texas urgent care center. It highlights the development and outcomes of using the 2024 American Diabetes Association guidelines to identify and educate undiagnosed individuals, emphasizing the role of early intervention in improving health outcomes in underserved communities.

Why Improving Access to Mental Health Care is an Ethical **Imperative**

An estimated one in four children has a serious mental health concern, and up to one in five of those who are pregnant and in the postpartum period will suffer from a maternal mental health condition. Primary care clinicians are tasked with assisting women in the perinatal period and children and their families with mental health needs, by utilizing the support of

a collaborative care program. This presentation will provide evidence for the rationale and outcomes of children, families. and women whose primary care physicians utilize an access network program.

How a Medicare Advantage Home-Visiting Supportive Care **Program Identifies Patients in Skilled Nursing Facilities**

Home-visiting supportive care programs are able to provide Skilled Nursing Facilities patients and families with information about services, such as hospice, and provide reassurance that there is support once they are home. A Survey of PMHNP Student and Alumni Attitudes Toward Individuals with OUD and an Update on the New Training Requirements for Prescribing Buprenorphine

Teenager Suffers Large Right MCA Stroke: A Case Report

A teenager presented to a hospital after an ATV accident for which orthopedic injuries were sustained. Helping Uninsured Texans Be Healthy: What Texas Nurse **Practitioners Can Do to Help Our Most Vulnerable Neighbors**
