This case-based presentation covers the FDA blueprint for opioid REMS education. Other topics discussed will cover complete psychosocial and medical history, biology and types of pain, creating a pain treatment plan (including PDMP, RX, and special populations), educating patients and caregivers (informed consent and PPAs included), managing patients on opioid analgesics and OUD (stigma and pathophysiology of SUD, medications to treat OUD).

8:45 - 10:15 am | Pediatric Renal Disease

Join this interactive session on common pediatric renal diseases and hypertension, focusing on pharmacological treatment in the pediatric setting.

Speaker: Katie Sigler, MSN, CPNP-AC

Katie is an Acute Care Pediatric Nurse Practitioner for the Nephrology service at Texas Children's Hospital in the Woodlands. She has experience as a PNP in the Dialysis and Apheresis service and the Emergency Center at TCH. Her current role and research focus on the ambulatory setting and children with renal disease and pediatric hypertension. She has served as President of the Houston Chapter of NAPNAP and most recently served on the board as Community Outreach Chair.

10:45 am - 12:15 pm | Pharmacology Viral Update

This session will provide an in-depth review of diagnosing and managing COVID-19, RSV, and influenza in adult patients. The session will focus on epidemiological trends, identifying high-risk individuals, the latest pharmacologic treatment options, and advances in vaccine prevention. With a thorough analysis of clinical guidelines and evidence-based practices, this session will equip healthcare professionals with the knowledge needed to optimize patient care and improve outcomes in the face of these viral challenges.

Speaker: Dr. W. Mike Brode, MD, FACP

Dr. Brode is a board-certified internal medicine specialist and assistant professor in the Department of Internal Medicine at Dell Medical School. He serves as the medical director of UT Health Austin's Post-COVID-19 Program and is a practicing hospitalist at Dell Seton Medical Center. As a clinician-educator, Dr. Brode emphasizes patient-centered care, focusing on evidence-based diagnosis and comprehensive treatment for vulnerable populations.

1:15 - 2:45 pm | Pulmonary Pneumonia Diagnosis & Treatment

This session will cover the diagnosis and management of pneumonia, including a detailed discussion of risk factors and diagnostic criteria. The presenter will also explore treatment strategies, comparing approaches for inpatient and outpatient care.

Speaker: Dominique Fontenot, MSN, APRN, AGACNP-BC

Domonique has 13 years of experience in the nursing field, primarily in critical care, with the last five years practicing as an AGACNP-BC. She began her APRN journey in critical care and has since transitioned to working with the pulmonary department of Houston Methodist Hospital Baytown.

3:15 - 4:45 pm | First Contact Migraine

Migraine is a chronic disease that is underdiagnosed, undertreated, and affects over 1 billion people worldwide. The condition can be very disabling and affects 1 in 5 women, largely due to the fluctuations in hormones during the woman's reproductive years. This presentation reviews the epidemiology of migraine, how to diagnose migraine, and the appropriate acute and preventative treatments, including information on migraine and menstruation, contraception, pregnancy, and breastfeeding.

Speaker: Dr. Karen Williams, DNP, FNP-BC, FAANP, AQH

Dr. Williams brings 40 years of experience in healthcare, specializing in an integrative approach to pain and headache management. Before retiring from the VA, she served on the Office of Nursing Service Pain Committee as a subject matter expert in alternative medicine and acupuncture for pain relief in veterans. In 2013, she completed a 300-hour medical acupuncture program and holds national certification in auricular acupuncture and certification as a Battlefield Acupuncture Instructor.

8:45 – 10:15 am | Bugs and Drug: Microbiology Overview and Antimicrobial Prescribing for the NP

Attend this session to gain an overview of essential microbiological diagnostics and their application in identifying and treating common bacterial infections in both inpatient and outpatient settings. The session will cover the appropriate selection and duration of antimicrobial therapies while emphasizing the critical role of antimicrobial stewardship in diagnostics and prescribing practices.

Speaker: Dr. Rachel Reitan, DNP, FNPc, MSN-Ed, CWS

Rachel has worked as an Infectious Disease NP in inpatient and outpatient settings for almost a decade. She chairs the Infection Control and Antimicrobial Stewardship Committees at United Regional Hospital in Wichita Falls. She has been a board-certified wound care specialist since 2017, and for her 2019 DNP project, she wrote about the indication for systemic antimicrobials in chronic wounds, published in Wound Research.

10:45 am - 12:15 pm | Menopause Update

This session will guide you through the normal physiological changes of menopause, provide a comprehensive overview of the Women's Health Initiative (WHI) study, and review key follow-up research findings. Additionally, it will cover the menopausal hormone therapy regime, equipping you with the knowledge and confidence to prescribe hormones effectively.

Speaker: Dr. Shelagh Larson, DNP, APRN, WHP, NCMP, IF

As an NP, Dr. Larson has specialized in women's healthcare for the past 17 years. While she has provided lectures across the country on all subjects related to the lifespan of women's health care, she has a fondness for her peers in Texas. She is a nationally certified menopause provider and a sexual health fellow granted by ISSWSH. She has served five years on the NPWH Board and almost 10 for TNP.

1:15 - 2:45 pm | Pharmacologic Management in Child Sexual Abuse

Child sexual abuse remains a critical issue in this country, posing numerous challenges for affected children, especially regarding their physical health. This presentation will provide a concise overview of child sexual abuse and focus on the medications used to treat STIs in these cases. It will also explore unique situations, such as human trafficking, where standard treatment protocols may need to be adapted.

Speaker: Sandra Onyi, APRN, PNP-PC

Sandra is a certified pediatric nurse practitioner specializing in child maltreatment in the REACH (Referral and Evaluation of At-Risk Children) Clinic. She has worked in this field since 2002. She is employed by the University of Texas Southwestern Medical Center and is the SANE (sexual assault nurse examiner) training facilitator for Children's Health Children's Medical Center. She is also a reviewer for the Journal of Pediatric Healthcare.

3:00 - 4:30 pm | Biologics, DMARDs, and Geriatric Medications

This presentation explores the complexities of prescribing medications for the geriatric population, focusing on optimizing treatment while minimizing adverse effects. Our presenters will provide an in-depth overview of biologic Disease-Modifying Anti-Rheumatic Drugs (DMARDs) and their relevance in the gerontology patient population, discussing their mechanisms of action, clinical applications, and considerations for use in older adults. This session will equip nurse practitioners with the knowledge to make informed decisions in managing chronic conditions and comorbidity risks in the elderly.

Speaker: Dr. Susan Quisenberry, DNP, APRN, CNP, FNP-C, and Dr. Susan Chrostowski, DNP, APRN, AGNP-C Dr. Quisenberry is a clinical professor at Texas Woman's University College of Nursing. She is a certified family

Dr. Quisenberry is a clinical professor at Texas Woman's University College of Nursing. She is a certified family nurse practitioner and, for the past 15 years, has worked exclusively with rheumatology clients. Her practice and scholarship activities are focused on patients with rheumatoid arthritis. She served as a clinical sub-investigator on over 150 rheumatology-focused clinical trials and published articles related to rheumatologic conditions.

Dr. Chrostowski is an associate clinical professor at Texas Woman's University and a practicing certified adult nurse practitioner. She has been working exclusively in rheumatology since 2005. Beyond her ongoing clinical practice with rheumatology patients, she has presented at local and national conferences on rheumatologic conditions, published articles related to rheumatology conditions, and served on multiple national rheumatology committees. Dr. Chrostowski is currently a board member on the American Board of Internal Medicine – Rheumatology Sub-Specialty Board.


