# ADDITIONAL SERVICES PROVIDED FOR A FEE

#### **REGISTERED AGENT**

Having a registered agent and address can be very useful to volunteer-managed organizations.

A registered agent provides a physical address for your organization for the receipt of important government notices for your Affiliate. The registered agent receives notice of a lawsuit or subpoena, which requires a timely response. If your Affiliate is ever sued, a sheriff or government official will hand-deliver legal documents to the registered agent.

The Secretary of State will list your registered agent's name, TNP, and address in their public records. Engaging TNP for this service means TNP's information, not your Affiliate's, is listed publicly. Anyone sending your Affiliate an official legal document will use TNP's address.

# What a Registered Agent is Not:

- A registered agent is not a virtual office for receiving all regular postal mail and packages for your business.
- A registered agent is not a tax address for your business.

Your Affiliate will need a PO Box for the regular business mail it receives.

FEE: \$100 (annual fee)

## TAX SUPPORT FOR AFFILIATES

As needed, TNP's team will prepare and file your Affiliate's:

- IRS Form 990N (e-postcard) with the IRS
- Comptroller franchise tax periodic information report
- Comptroller no tax due report
- Corporate periodic report and provide instructions on filing

FEE: \$350 (annual fee)
